The acceptable proof of Identity of the candidate shall be his **PAN card** or **Driving License** or Photo ID Card issued by State/Central Government bearing his signature or **Photo ID Card of IEI** or first page of his passport. Name in the ID Proof and the name of the candidate as registered with IEI must be the same. The ID proof should be self-attested.

A member attached to a Division shall be eligible to submit self-nomination for election only in that Division. The earnest money is acceptable only by **Demand Draft** and must be submitted along with the nomination papers. The earnest money paid during submission of nomination shall not be refunded under any circumstances.
